### Job description

- Establish a working relationship with the Kaihautū to ensure that we both have oversight of all the Runanga's finances.
- 2. Ensure there is a proper record of all payments and monies received.
- 3. Ensure financial reports are available and understood at all whanau hui.
- 4. Show evidence that money received is banked and documentation provided for all money paid out.
- 5. Ensure that information for an audit is prepared each year.
- 6. Liaise with office staff through the Kaihautū on any issues relating to the finances.
- 7. Keep the executive fully briefed on all transactions that require their attention.
- 8. Establish a relationship with the Runanga's accountant and Auditors to ensure clear communication is a priority.

I was motivated to accept this role because the whanau wanted me to take up this leadership.

#### What do you want to achieve in this role?

I see myself as a servant to the whanau and rely on their continued support for the mahi that I do.

**Anything else you would like to share with whanau** What I want to achieve in this role are the following:

- 1. Integrity in the way in which I implement the financial policy on behalf of whanau
- To provide clear reporting back to whanau that gives them the information they need to make the right decisions on behalf of Taumutu whanau and more particularly our mokopuna in the future.
- 3. Successional planning is very important to me so to encourage members of the whanau to see the role of Treasurer as a learning opportunity and an opportunity to give back to their whanau.

Although I don't whakapapa directly to Moki or Ruahikihiki our whakapapa is linked through Porourangi and Potiki. My mother was Ngati Porou and I was born in Otautahi and have been nurtured by Ngai Tahu all my life. I am a servant only to the people and have established my own rangatiratanga in my whanau through my husband Pari Hunt and our children who are Ngai Tahu and Ngati Porou/Te Atiawa. I am fortunate and humbled to be the treasurer and contributing to the future of all our mokopuna.

## Investment Wananga

Whanau came together on Sunday 7 May with Te Runanga o Ngai Tahu staff (Wayne Vargis and Ben Rereti-Jones) to discuss Rūnanga investment. Te Taumutu Charitable Trust is tasked with delivering investment returns. The trustees are Graham Nutira (Chair), Pari Hunt (Deputy Chair), Maru Rout, Megen McKay, Sam Brown and Malcolm Wards. Almost all trustees attended the wānanga to hear whanau views. The trustees have been tasks with working with Wayne and Ben to draft a Statement of Investment Policies and Objectives (SIPO). A SIPO sets out an investment governance and management framework, philospy strategies and objectives. It will direct us on ethical investments and spreading investment risk.

# Ngāi Tahu Pūrākau Wānanga

Pūrākau have been used to dispossess, but pūrākau can also be used to empower.

Over the weekend of 26-28 May 2023, the Ngāi Tahu Pūrākau wānanga was held at Taumutu. Facilitated by Maurice Manawatu from the Ngāi Tahu Archive unit, with assistance from Joseph Hullen & Rocky Roberts, and anchored by Tā Tipene O'Regan. The Ngāi Tahu Pūrākau wānanga looked in depth and discuss Ngāi Tahu pūrākau. The theme of this wānanga at Taumutu was around our creation stories.

During the wānanga, attendees broke off into three groups to look at the kōrero contained in the manuscript of Matiaha Tiramorehu, the kōrero captured from the Ruapuke/Rakiura/Murihiku region by the missionary Johann Wohlers and the kōrero shared to Herries Beattie by Teone Taare Tikao. After reassembling, each group presented back to everyone their examination of the manuscript or writing, with the opportunity to have a much larger group discussion.

Friday evening following mihimihi, David Perenara O'Connell gave a kōrero about Taumutu and Te Pā o Moki.

Saturday morning saw Tā Tipene give a background to the Kāi Tahu Kawa hui that was held at Taumutu in 1971. In the afternoon we visited Muriwai, Orariki Pā and Whakamatakiuru, with a roadside stop along the way within the vicinity of Waiwhakaheketupapaku. At each location, kōrero was shared about the history and importance of these locations to our hapū. Saturday evening, we were treated to a preview of the new 2D animations coming out from NĀIA, that capture tipuna stories and their exploits.

Sunday the wananga looked at and discussed the Pacific creation stories, presented in a 1916 manuscript from Harvard University.

There was lots of laughter with perfect weather and our ringawera kept everyone well nourished.

Two more wānanga are planned for this year, one at Arowhenua and one at Makaawhio.
